# Under Eighteen Years of Age.

To the Honorable Judge of the Court of Common Pleas of Cambria County, State of Pennsylvania.

The Petition of Anthony Ashpuck  
a native of Germany respectfully sheweth:

That he declared on Sept 7<sup>th</sup> 1896 before the Prothonotary of this honorable Court, on this day, that it was bona fide his intention to become a citizen of the United States, and to renounce forever all allegiance and fidelity to any foreign Prince, Potentate, State, or Sovereignty whatever, particularly to the

King of Germany; that at the time of his arrival he was Under Eighteen Years of Age; that he has continued to reside in the United States since that period; that for three years previous to his arrival at full age it was, and still is, bona fide his intention to become a citizen of the United States, and of renouncing forever all allegiance and fidelity to any foreign Prince, Potentate, State, or Sovereignty whatever, and particularly to the

King of Germany, of whom he was at the time a subject; that your petitioner has resided within the United State upwards of five years, and in the State of Pennsylvania one year, both periods immediately preceding this his application to become a citizen of the United States; and that he has never borne any hereditary title, or been of any of the orders of nobility, in his own or any other country.

He therefore prays that, on his making the proof and taking the oath prescribed by law, he may be admitted a citizen of the United States of America; and he will ever pray, etc.

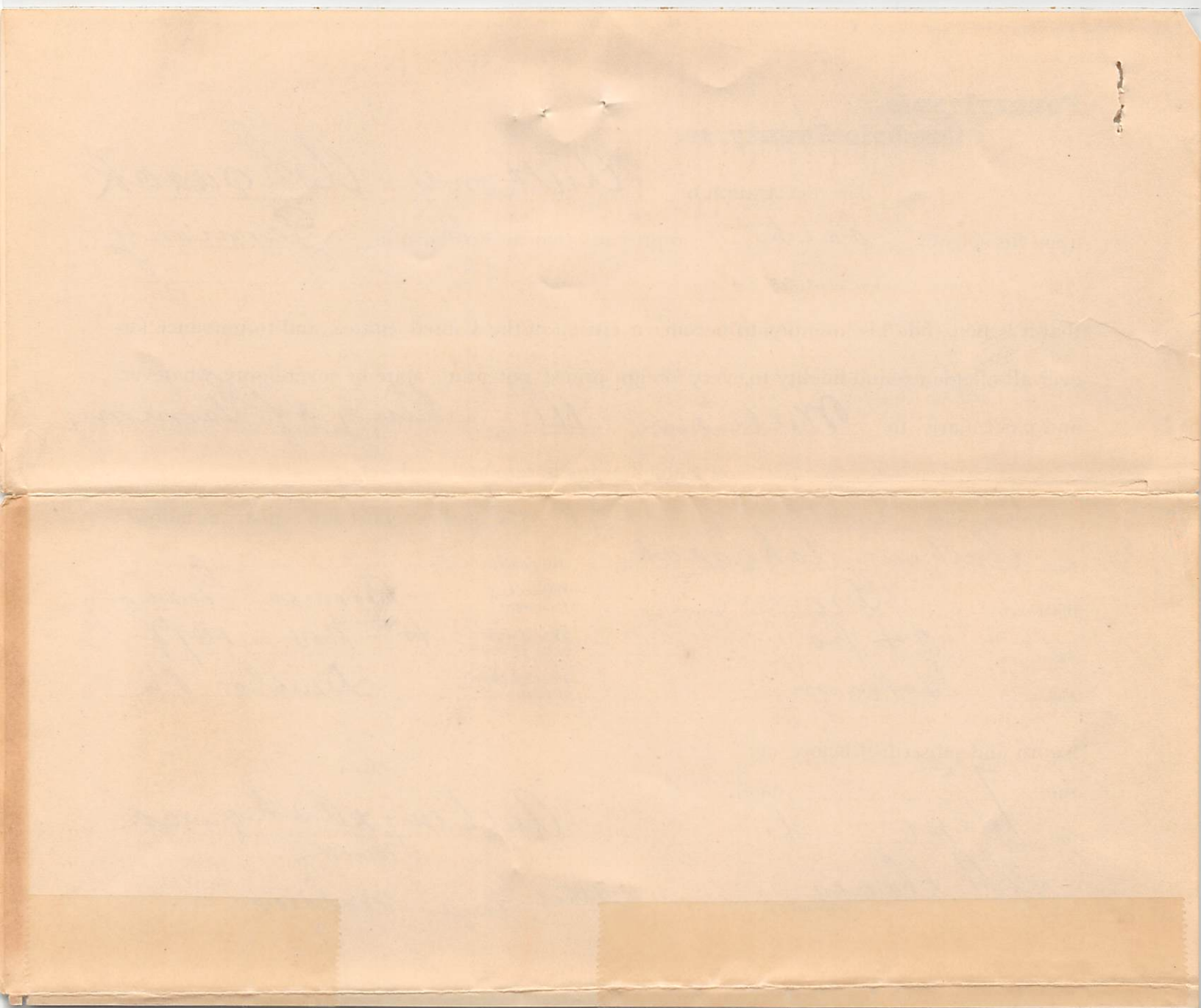
