Sec. 2167: The petition of Abel Blarel

Respectfully represents: That he is a native of France, that he has resided

in the United States of America three years next preceding his arriving at the age of twenty-one years and continued to reside therein to the time of making this application; and has resided in the United States continuously for five years at least, and that he has resided in the State of Pennsylvania one year at least previous to making this application; that he is now twenty-one years of age and upwards; that he does not disbelieve in nor is he opposed to all organized government; that he is not a member of, or affiliated with, any organization entertaining and teaching such disbelief or opposition; that he does not advocate or teach the duty, necessity or propriety of the unlawful assaulting or killing of any specific individual or of officers generally, of the Government of the United States or of any other organized government, because of his or their official character; and that he has not violated any of the provisions of an Act of Congress entitled "An Act to regulate the Immigration of Aliens into the United States," approved March 3, 1903. He therefore prays your Honor to admit him to become a citizen of the United States of America agreeably to the Act of Congress in such case made and provided.

Sec. 2165 (2) I, Abel Blarel, the petitioner above named, do

swear that the facts set forth in this petition are true; that for upwards of two years next preceding it has been my *bona fide* intention to become a citizen of the United States; that I will support the Constitution of the United States, and that I absolutely and entirely renounce and abjure all allegiance and fidelity to every foreign prince, potentate, state or sovereignty, and particularly to the

of which I was before a subject.
